DEBIT CARD CHANGES

Beginning August 15, 2010, we will not authorize and pay overdrafts for the following types of transactions unless you authorize us to:

ATM transactions
Everyday debit card transactions

To OPT IN and continue overdraft coverage, Debit Card members must sign and complete the Authorization Form that can be found on our Web Page, in the Credit Union Office or mailed with your May Statement.

The Credit Union will charge you a fee of \$25.00 each time we pay an overdraft. There is no limit on the total fees we can charge you for overdrawing your account.

If we don't receive an Authorization Form ATM and everyday Debit Card transactions will be declined if funds are not available.

You may revoke this OPT IN consent at any time.
